Project Scope & Duration:

The Scope of work will broadly include the Engineering, Procurement, Construction ("EPC") for the upgrading of the existing carriageway from two lane to four lane for 22.700 km on EPC mode with horizontal and vertical alignment improvements, construction of new pavement, construction and/or rehabilitation of major and minor bridges, culverts, road intersections, interchanges, drains, road safety enhancements etc.

Construction period is 18 months and the contractor shall also maintain the developed facilities for a period of 5 years from the date of issue of Provisional Certificate of Completion.
