The Tamil Nadu Road Sector Project -II, (the "Authority") intends to take up Strengthening and Widening (Four Lane) of Tirunelveli – Sengottai – Kollam Road of SH-39 ("The Project State Highway") from Km 5+000 to Km 50+600 in the State of Tamil Nadu under TNRSP-II to be executed on Design, Build, Finance, Operate, Maintain and Transfer (DBFOMT) on Modified Annuity Basis excluding the cost of Construction of Project Highway in the stretch from Km 28+000 to Km 31+000 (which will be paid on BOQ Basis) and to finalize and constitute the firm for Independent Engineer.

  - d. Experience of the firm in DPR preparation/Design Review/ Supervision of Major highway structures of length more than 30 m during last 10 years

- 3. The IE shall be responsible for the review of designs prepared by the Concessionaire, including drawings and specifications, superintendence of the Concessionaire's performance under the Concession Agreement (CA), progress monitoring, technical and quality control, evaluations of construction, certification and completion of the works by the Concessionaire, and duties related to taking over and the defects liability period. The IE shall be present at all times during the day-to-day implementation of the Design and Construction Periods and as required for the fulfillment of its assignment during the Operation and Maintenance Period. Having been appointed by the Authority, in consultation with the Concessionaire, and delegated specific authorities in the CA, the IE shall be fully responsible for superintendence of the Concessionaire's performance in all phases of the CA. The IE shall at all times, be adequately staffed, in terms of numbers and professional skills, to carry out its responsibilities with the competence and diligence required for this assignment.
- 4. The scope of the services shall include: (background note is available in <a href="https://www.tnrsp.gov.in">www.tnrsp.gov.in</a>)
  - Review of the Drawings (working and as-built), Specifications and related Documents including detailed engineering and design documents, design and construction progress reports prepared by the Concessionaire;
  - Review, inspection, and superintendence of the Construction Works including environmental management plan, resettlement action and Social safeguard plan, traffic management program, work zone safety plan and other special management

- programs as set forth in the CA; work with the Concessionaire to ensure timely and on budget execution of the road works;
- Ensure the Concessionaire's fulfillment of his quality assurance plan by visual observation, random measurements and laboratory tests. Conducting tests and inspections on completion of construction and issuing Completion/ Provisional Completion Certificate as set forth in the CA;
- Co-ordination with stake holders including, performing relatedduties and functions, as necessary for the Concessionaire's successful and timely completion of the Highway Project under the CA.
- Certification of payments;
- Review, inspection and superintendence of O&M as set forth in the CA;
- Contract administration;
- Review, inspection and monitoring of divestment requirements as set forth in the CA;
- Assisting the Parties to the CA in resolving disputes, differences or controversies in accordance with the applicable provisions of the CA and Dispute Resolution Clause of the CA;
- Determining the costs of any works or services and/or their reasonableness, as required under the CA;
- Determining the period or any extension thereof, for performing any duty or obligation as required under the CA
- Reporting progress of the works on a monthly basis;
- Cooperating with the Third Party Quality Monitoring Team appointed by the Authority to carry out its tasks;
- Undertaking all other duties and functions in accordance with the CA.
