Bidders will be required to register on the website. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
- 6. For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. Tenderers can see the list of licensed CAs from the link <a href="www.cca.gov.in">www.cca.gov.in</a>.
- 7. Bids must be supported by a Bid-Securing Declaration in prescribed format (Section IV Bidding Forms Forms of Bid-Securing Declaration). Bids must be submitted online on www.tntenders.gov.in on or before the date and time for receipt of bids, and will be opened online on the specified time and date for opening of bids, as given above. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.

The bidders are required to scan and upload (a) Bid-Securing Declaration, (b) Power of attorney to sign the bid and (c) affidavit regarding correctness of information furnished with bid document while submitting bids in the e-procurement portal (www.tntenders.gov.in). Only successful bidder is requested to submit the above-mentioned original documents before signing of agreement.

Bids must be submitted online on www.tntenders.gov.in on or before 15:00 hours on 10.03.2021 and will be publicly opened online on the same day at 15:30 hours, in the presence of the bidders designated representatives who wish to attend. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The electronic bidding system would not allow any late submission of bids.
- 10. An online pre-bid meeting will be held on 17.02.2021 at 12:30 hours at the Office of the *Superintending Engineer (H), ICERS Cell* to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of 'Instructions to Bidders' of the bidding document. Bidders are advised to download the bidding document prior to the

pre-bid meeting in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
